The Stephenson Locomotive Society is a private company limited by guarantee, registered in England and Wales as Company No. 10471004. (Our Registered Office is at 23 Woodland Road, DARLINGTON DL3 7BJ.)

Members pay an annual subscription giving full Membership benefits (which includes six Journals per annum (excluding Second Family Members), access to our library, meetings (both at our local Centres and by ZOOM) and full voting rights.

Available Membership categories are (rates are all per calendar year):

ORDINARY: Available, to persons over 18 years of age, for £30.00 but in their first year the rate is only £15.00.

(Reduced rate is not available to former members until one year after they were last a member.)

JUNIOR : Available to persons under 18 years of age, for £10.00. (Proof of date of birth will be required.)

FAMILY : Available where two or more Members reside at the same address, but only a single copy of each Journal will be supplied to that address, for £20.00 per person.

(NB. The first-named person will be held responsible for all the payments.)
